



If you lose your job, your rent still gets paid.

Greenlight Bridge covers up to \$6,000 in rent if you lose your job unexpectedly, with pricing based on how many months of coverage you choose.



Policies start as low as \$9.99 a month.¹ This is an annual policy paid monthly, so you get a full year of protection without a big upfront cost.

How it works

You enroll and pay monthly. If you lose your job and your claim is approved, rent goes directly to your property for the number of months you chose, so you can focus on finding your next job instead of falling behind.

What to know

Greenlight Bridge is built for full-time employees.

To receive a payout, you'll need to have been working full time, to have lost the job through no fault of your own (a layoff, not a resignation or a firing for cause), and to have been unemployed for at least 30 days.

Coverage also begins 120 days after you enroll.

It won't cover a job loss that already happened, or one that happens during those first 120 days, which is why enrolling at move-in is the best time to do it.²

What it costs

Policies start as low as \$9.99/month.¹ Your price depends on your rent and how many months of coverage you choose.

Getting started

You can enroll any time during your lease, just ask your property manager to send you an invitation link. Once you're in, choose how many months of coverage you want. Earlier is better, since coverage doesn't start until 120 days after you enroll.

If you lose your job

Let your property know you have Greenlight Bridge, then file your claim at [MyIncomeJobLoss](#). Claims are handled by MyIncomeJobLoss, not by Greenlight Rent.

You'll need proof of job loss, pay stubs from your last three months, and your state unemployment approval letter. It helps to gather these early, since you'll also need to have been unemployed for 30 days before a claim can be approved.

Once your claim is approved, rent is paid straight to your property manager for as long as your coverage lasts.
